Investment objectives of the fund


The fund's objective is to deliver income and capital growth over the longer term by investing primarily in exchange traded products and tracker funds to gain exposure to the investment market. The fund has a higher exposure to shares (around half of the portfolio) than our Cautious fund. It also has significant exposure to bonds and may have exposure to other non-equity asset classes.




